## **Seller and Buyer Requirements**

### **SELLER's Requirements:**

1. Registration is required. A one-time fee of \$5.00 will be charged to register.
2. A Seller's place in the auction line-up will be decided on a first come basis.
3. A Seller's registration form can be downloaded at: <http://www.flyaways.org>
4. Pre-registration is encouraged. Download the registration form, fill it out, and e-mail as an attachment to [president@flyaways.org](mailto:president@flyaways.org), or, mail to: Fly-A-Ways RC Club, c/o Scott Enochs, 13439 NW Ford Rd., Gaston, OR 97119. Registration will also be accepted at the auction hall from 8am-11am, Saturday, Feb 18, 2012.
5. The auction hall will be open from 8am-11am, Saturday, Feb 18, 2012, for Seller registration and check-in of sale items. The \$5.00 registration fee is required at check-in. Auction starts at 12 noon.
6. Sale items cannot be brought into the building until the Seller has registered and checked in. Each Seller will be issued a Sellers ID number. All sale items must be labeled with the Seller's issued identification number. ID stickers will be issued at the registration table. After items are tagged they will be moved to the auction tables in order of registration. Sellers are encouraged to answer questions from potential buyers about their sale items.
7. The minimum opening bid on every item will be \$10. If need be, multiple items should be grouped together to make the \$10 opening bid. Minimum bid increase will be \$5. There will be ***no*** "minimum bid" value accepted for any item. A Seller may bid on their own sale items if the bid is below their expectations. If the Seller's bid is the highest, the item will be listed as sold to the Seller and the Seller is liable for the 10% commission on the sale (see item 9). Items that do not receive a bid will be listed as having been sold to the Seller for \$0 and removed to the Impound area for pick up by the Seller.
8. Sold items will pass from the auction table to the Impound area. They will be kept there until the buyer has paid for them.
9. FLY-A-WAYS will retain a 10% commission on each item sold up to a selling price of \$300. For any item with a selling price greater than \$300 there is no commission charged on portion of sale in excess of \$300 (ie, maximum commission \$30 per item).
10. All Sales are Final.
11. Seller will be paid by check from FLY-A-WAYS ***after*** all Buyers have submitted payment for Seller's items. If necessary, FLY-A-WAYS will mail a check if the Seller needs to leave the auction hall before all Buyers have made payment.

### **BUYER's Requirements:**

1. Registration is required. A one-time fee of \$5.00 will be charged to register.
2. The Buyer will be issued a paper plate with his bidder's number.
3. The auction hall will be open for Buyer registration from 11am-12 noon, Saturday, Feb 18, 2012. Auction starts at 12 noon.
4. Do not lose your Bidder's Number. You are responsible for all items purchased using that number.
5. The starting bid on every item will be \$10. Minimum bid increase will be \$5.
6. To check out, go to the Check-Out cashier to pay for your purchases. Present your Buyer's bid plate and you will be given a check-out sheet to present to the Impound area to retrieve your purchases.
7. Only cash or personal checks will be accepted for payment. We cannot accept Debit or Credit cards of any type.
8. Items picked up from the Impound area must be removed from the building immediately. Do not bring items back into the auction area.
9. FLY-A-WAYS is not responsible for the condition or quality of any item sold at the auction. It is the Buyer's responsibility to understand what they are bidding on. Buyers are encouraged to inspect and ask questions about items ***prior*** to the start of the auction.
